INTEREST RATES and INTEREST CHARGES:

Annual Percentage Rate (APR) for Purchases & Balance Transfers	13.00%, 14.00%, 15.00%, 17.00% or 18.00% depending on your credit history. This APR will vary with the market based on the Prime Rate.
APR for Cash Advances	15.00%, 16.00%, 17.00% or 18.00% depending on your credit history. This APR will vary with the market based on the Prime Rate.
Paying Interest	Your due date is at least 21 days after we mail your billing statement. We will not charge you interest on purchases if you pay your entire new purchase balance by the due date each month, otherwise we will charge you interest as of the date the purchase transaction posted to your account. We will begin charging interest on cash advances and balance transfers on the date the transaction posts to your account.

Fees to Open or Maintain your Account - Annual Fee: - Application Fee:	None None
Transaction Fees - Balance Transfer: - Cash Advance: - Foreign Transaction:	3% of the amount of each transfer (minimum of \$30.00) \$10.00 or 3.00% of the amount of each cash advance, whichever is greater. None
Penalty Fees - Late Payment: - Over-the-Credit Limit: - Returned Payment:	Up to \$27.00 or the amount of the required minimum payment, whichever is less, if you are one (1) or more days late in making a payment. In the event you fail to make a payment on time in any of the six (6) billing cycles following the initial violation, you will be charged up to \$38.00 or the amount of the required minimum payment, whichever is less None Up to \$27.00 the first time your payment is returned for any reason within the following 6 billing cycles, you will be charged up to \$38.00 for each returned payment.

How We Will Calculate Your Balance: We use a method called "average daily balance (including new purchases)."

Minimum Payment Requirement: \$25.00 or 2% of balance plus the full amount of any balance in excess of your credit limit.
